## Level 3 Award for Professional Investigators

The government commissioned the Levenson Enquiry and The Parliamentary Home Affairs Select Committee (PHASC) to look at both the culture of the media but also the practices of investigators in the private sector. Both Inquiries found in favour of PI licensing. The PHASC recommended that licensing include that investigators have sufficient training and hold the “approved qualification”. The role out of licensing was proposed for 2015 and is likely to come into fruition in the short term.

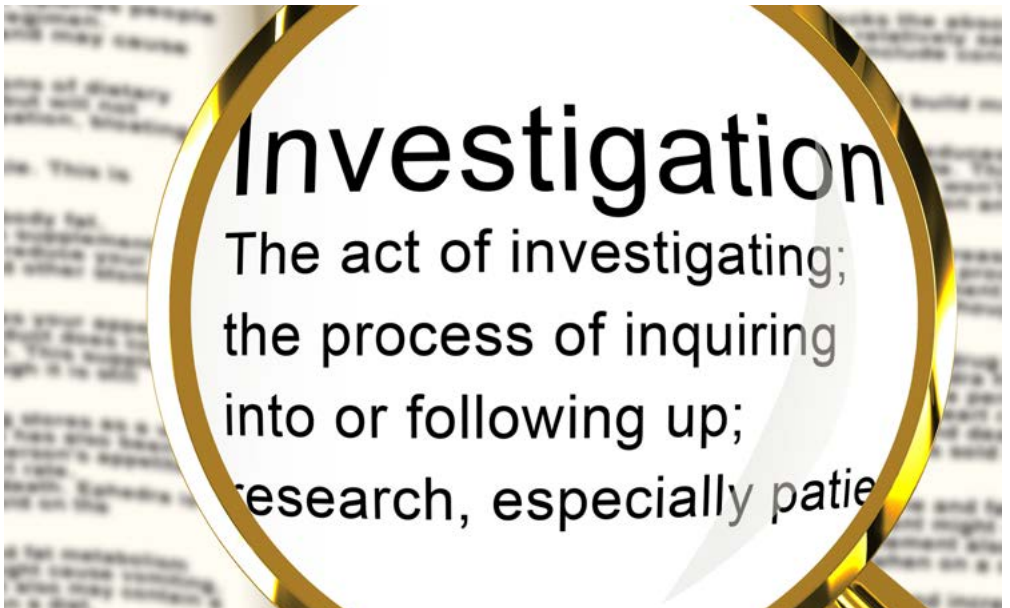

## Content
